# MEASURES TO BE TAKEN BY RELEVANT STAKEHOLDERS FOR CONTROL OF CONGO FEVER (CRIMEAN-CONGO HEMORRHAGIC FEVER) IN PUNJAB

I am directed to refer to the subject cited above and to state that, in view of the recent emergence of **Crimean-Congo Hemorrhagic Fever (CCHF)** cases and the potential risk of its spread, the following guidelines are issued for strict and immediate compliance by all concerned departments and authorities:

#### i. Local Government & Community Development Department / Punjab Cattle Market Management & Development Company:

- Implement anti-tick spraying, limestone marking, and fly repellent measures in slaughterhouses and cattle markets.
- Ensure availability of anti-tick sprays and ivermectin; separate and treat animals with ectoparasites.
- Initiate similar measures in dairy and gawala colonies.
- Display awareness materials at prominent locations in cattle markets (e.g., banners on disease reporting via ADRS Info App).
- Establish 24/7 helplines and farmer facilitation desks in all cattle markets.
- CEOs of cattle markets must stay in close liaison with Commissioners of highrisk areas (Rawalpindi, Gujrat, Sargodha).

#### ii. Transport Department:

- Issue necessary instructions to goods transport associations and truck loading points for lime application and hygiene compliance.
- Ensure proper disinfection of trucks before loading animals.

### iii. District Administration / Metropolitan & Municipal Corporations / Zila Councils:

- Launch awareness campaigns for farmers and stakeholders on safe handling of animals and waste.
- Utilize veterinary staff for tick control operations.
- Conduct regular tick-repellent spraying at animal sale points.
- Ensure safe disposal of animal waste and control of fly breeding.
- Enforce use of protective gear (gloves, long-sleeved clothing) for animal handlers.
- Disseminate public awareness messages via social media, FM radio, and local media.
- Disinfect and limewash walls/floors and seal cracks in slaughterhouses, cattle markets, and tanneries.
- No animal shall be allowed entry/exit from cattle markets without prior veterinary inspection.
- Animal sale/purchase shall remain under DC supervision; animals infested with ticks are strictly prohibited for trade.

#### iv. Health & Population Department, Punjab:

- Follow the advisory issued by the Center for Disease Control (CDC), NIH Islamabad (dated 15<sup>th</sup> April, 2025).
- Focus on early symptom identification, timely lab testing (as per NIH criteria), and reporting (<a href="www.nih.org.pk">www.nih.org.pk</a>).

#### v. Punjab Police / National Highways & Motorway Police:

- Facilitate and support L&DD staff at all established check-posts at provincial entry points.
- Ensure cooperation at Motorway toll plazas for setting up anti-tick/screening posts.
- Provide security to staff working round-the-clock at anti-tick checkpoints.
- 2. I am further directed to convey that all concerned departments are requested to ensure immediate implementation of the above directions in letter and spirit to prevent any further spread of the disease.
